Dear Mr. Pearson:

This letter and attachment are provided by The Regents of the University of California in response to PERB's letter dated May 27, 2021, in the above-referenced matter.

Enclosed is a list of Graduate Student Researchers ("GSRs") and Graduate Student Assistant Researchers ("GSARs") appointed to the following title codes as of April 30, 2021 for those paid on a monthly basis and on May 15, 2021 for those paid on a bi-weekly basis: 3262, 3263, 3264, 3266, 3273, 3274, 3276, 3282, 3283, 3284, 3285, 3286 and 3287. In total there are 10,789 individuals in these titles codes as of the dates mentioned above.

There are no individuals who serve as Research Assistants as defined by Academic Personnel Manual 112-4-b-47. This title has not been in use since approximately 2012.

The Regents request an extension of 28-days (until Wednesday, July 14) to respond to UAW's Representation Petition, Attachment A, (3)-(5). This additional time is needed because unlike those identified in the GSR and GSAR title codes above, the graduate students identified in Attachment A, (3)-(5) are not employees of the University and thus, a central repository is not available for the requested information.

The Regents agrees with UAW's statement that the proposed unit will not include the following: (1) supervisors, managers or confidential employees; (2) all employees of the Lawrence Livermore National Laboratory and Los Alamos National Laboratory; (3) all employees in title code CWR003; (4) all positions that are exclusively represented at the time of this petition; and (5) all staff positions covered by the University of California Office of the President ("UCOP") Personnel Policies for Staff Members ("PPSM"). The Regents further reserves the right to seek exclusion of other titles and appointments, including those referenced above.
